## **LEAD CONTRACTOR TRAINING**

**5 DAY - \$865.00**

This 40-hour Lead Abatement training course is required by the Ohio Department of Health to apply for a Lead Abatement Contractor license. This training course uses both the EPA model Lead Abatement Contractor curriculum, HUD Guidelines, and includes OSHA and EPA compliance requirements. The class focuses on identification of safe work practices and job specifications for controlling hazards of lead paint, dust, and soil. Table top exercises are used to teach how to choose abatement methods that are most cost-effective. Trainees participate in hands-on demonstrations of abatement techniques, personal protective equipment, and environmental testing methods. The training's goal is an individual who has the knowledge to be responsible for supervising safe, effective residential lead abatement projects.

**COURSE TOPICS** Current and Pending Regulations, Recognition and Control of Hazards, Toxicology of Lead, Effective Employee Training and Protection, Project Supervision Techniques, Estimating Costs of Abatement Jobs, Waste Disposal Issues, OSHA Compliance Requirements, Pre-Abatement Plan Preparation, Legal Liabilities Associated with Lead Abatement, Ohio Department of Health Rules, HUD Guidelines, Hands-on Demonstration of Abatement Techniques.

**WHO SHOULD ATTEND:** Environmental and asbestos abatement contractors, industrial hygienists, environmental consultants, architects, housing professionals, painting contractors, abatement supervisors, demolition contractors, renovation and remodeling contractors, general contractors, project designers, and policy makers.

## **LEAD WORKER TRAINING**

**5 DAY - \$665.00**

The typical Lead Abatement Worker training course is a 32-hour training course. However, this class is being taught as the Lead Abatement Contractor class and is a 40-hour training course and satisfies the Ohio Department of Health requirements for the Lead Abatement Worker course.

## **LEAD CONTRACTOR / WORKER REFRESHER TRAINING**

**1 DAY - \$225.00**

This 8-hour Lead Abatement Refresher training course is required by the Ohio Department of Health to reapply for a Lead Abatement Contractor license. Per the Ohio Revised Code 3701-32-04 (G)(1)(a): A lead abatement worker may take a lead abatement contractor refresher course in lieu of a lead abatement worker refresher course. A licensed person must successfully complete the appropriate Ohio-approved refresher course within two years of their initial training or previous refresher course. *If refresher training is not completed within two years the initial course must be repeated.*

**COURSE TOPICS:** Health effects of lead, regulatory updates including ODH rules and EPA/HUD regulations, abatement strategies and controls, and various review exercises.

**WHO SHOULD ATTEND:** Lead Abatement Contractor and Lead Abatement Workers.
