OSHA Now Requires Specific Training for Scaffold Erectors and Users: "Scaffold shall be erected, moved, dismantled, or altered only under the supervision and direction of a competent person, qualified in scaffold erection, moving, dismantling or alteration. Such activities shall be performed only by experienced and trained employees selected for such work by the competent person. The employer shall have a competent person determine the feasibility and safety of provided fall protection for employees erecting or dismantling the scaffolding."
